



An all Limestone farmhouse was built in the mid 1700's, has approx. 1,960 sq. ft.; large eat-in kitchen w/ abundant updated Oak cabinetry & walk-in stone fireplace (now has cabinet storage); large living room; storage room; roomy main level laundry; summer kitchen; main level full bathroom; covered front & side porch. Second level has 4 bedrooms; half bathroom; original plank flooring & banister; unimproved basement. Deep window sills thru-out; good metal roof; on-site well & septic; newer water treatment system & filter; updated oil fired furnace, H/W baseboard heat.

BARN & BUILDING DETAILS: Huge 1700's bank barn w/ repointed stone wall all the way to the peak (back was sprayed with shotcrete); barn has newer metal roof (2014) & sheep/horse shelter in bottom level; approx. 7 acres enclosed with high tensile fencing; spring fed pond; large 1-car garage; 2 equipment barns; corn barn; 2 concrete silos; Clean/Green program; Millcreek Twp.; E. Leb. Co. School Dis-



trict; reasonable annual taxes approx. \$3,714.31. This property has an easement right-of-way for the railroad. A large stone private tunnel gives access to the land on the other side of this easement.
